

Bathing Regulations of the CASSIOPEIA THERME

General

- Each guest must behave in such a way as not to endanger the safety, order, cleanliness and conventions of the CASSIOPEIA THERME.
- The supervision of children is generally the responsibility of the parents or guardians.
- The staff of the house exercises the domiciliary rights towards all visitors. We are happy to receive requests, suggestions and criticism, if possible in writing.

Swimming costume

- The use of the thermal baths is done in usual swimwear. This means a swimming costume or bikini with top for women and briefs or swimming shorts for men. Knee-length or longer swimming shorts, tankinis, swimming skirts or full-length swimming costumes are not permitted. Underwear underneath the swimming costume is not permitted. Bathing caps are not required.
- For hygienic reasons, the pools and sweat rooms in the textile-free areas may only be used without a swimming costume.
- Babies and small children may only stay and bathe in the baths with waterproof diapers. These diapers can be purchased from the bathing staff.

Risk of slipping, bathing shoes

- Every guest should be aware of the increased risk of accidents in swimming pools due to wet floor surfaces. Therefore, special care should be taken in all guest areas and non-slip bathing shoes should be worn outside the pools.

Hygiene requirements

- For reasons of hygiene, we ask you to take a shower before bathing. If you apply cream or oil in the meantime, you must shower again before entering the swimming pools.
- For reasons of hygiene and aesthetics, shaving, nail cutting, hair dyeing and similar personal hygiene procedures are not permitted.
- In the sweat rooms, a sufficiently large towel must be placed under the whole body (including the feet) to avoid contamination of the benches.

Deck chairs

- It is not permitted to reserve seats or loungers with towels, bags or other objects. If objects are left on them, they may be removed by the spa staff themselves or at the request of the guests.

Food and drink

- Food and drinks may only be consumed inside CASSIOPEIA THERME at the tables provided for this purpose in the bistro area. The consumption of food and drink brought in by guests is not permitted.
- In principle, it is forbidden to bring alcoholic beverages and fragile containers and/or glass bottles.
- The consumption of alcohol is limited to a reasonable amount. CASSIOPEIA THERME reserves the right to limit the number of alcoholic beverages per principle and per guest, and to prohibit alcoholic guests from continuing their consumption and to expel them from the baths in the event of danger or disruption of the baths.

Smoking

- Smoking is not permitted inside the entire CASSIOPEIA THERME, including the foyer. Outside, smoking is only permitted in the designated areas (smoking areas). This also applies to electronic cigarettes. The carrying, smoking or any consumption of cannabis is prohibited in all areas of the bath, including the outdoor areas.

Mobile phones and cameras

- The use of mobile phones and sound and image recording equipment is not permitted in CASSIOPEIA THERME. Photographs and films may only be taken with the express permission of the management.
